#### **Balance Sheet Notes**

As of Sep 30, there was \$395,503 in cash, representing 20 days of cash on hand (benchmark = 60 days) and a current ratio of 1.1 (benchmark = 2). Cash was low due in large part to several large payments made in September on building improvements and settlement/closing costs. Receivables for the current year were at \$694,704.

#### **Income Statement**

As of Sep 30 (approximately 25% of the way through the fiscal year) we recognized 21% of budgeted income and 18% of budgeted expenses, resulting in an operating net income of \$217,376 (a net loss of -\$316,042 when including capital project expenses). Local revenues are under budget. This month we will compare budgeted rates to the currently approved 363 rates to examine the variance.

#### **Year End Projection**

As of Sep 30, the Year-End Projection shows an operating net loss of -\$255K, primarily due to lower-than-budgeted district revenues and higher salary expense. As mentioned above, we will examine the variance and address this matter prior to the next report. The projection is an extrapolation of current activity and not meant to be predictive.
