Balance Sheet Notes

As of Nov 30, there was \$690,191 in cash and a current ratio of 3.3, meaning current assets are sufficient to meet current liabilities. Tuition receivables stood at \$499,845 for the current year and -\$50,488 for last year. Accounts payable was higher than usual in Sep 30, and those invoices have since been paid. Those payments, plus the addition of credit card detail, account for the large number of transactions on the disbursement reports. This report includes audited 2016-2017 figures.

Income Statement and Projection Notes

As of Nov 30 (approximately 42% of the way through the fiscal year) we recognized 38% of budgeted income and 38% of budgeted expenses, resulting in an operating net income of \$69,144 (a net loss of -\$313,084 when including capital project expenses). The End of Year Projection on page 7 calculates an operating loss of -\$585,135, primarily due to local revenue. Though we are meeting overall budgeted enrollment, changes to district rates, special ed enrollment, and the distribution of student residence results in year-end estimates that are lower than budget.

Budgeted vs. actual enrollment is detailed in the chart below. We budgeted for a total of 400 students. Our actual enrollment in is very close to budget at 401, but the difference in the distribution amongst the districts accounts for a \$595K loss in tuition. Please note that spending adjustments and the timing of purchases may not be captured in this projection; it is only an extrapolation of current activity.
