Balance Sheet Notes

As of May 31, there was \$582,967 in cash, representing 32 days of cash on hand and a current ratio of 1.5 (benchmark = 2). Tuition receivables were at \$445,965 for the current year.

Income Statement

As of May 31 (approximately 92% of the way through the fiscal year) we recognized 84% of budgeted income and 91% of budgeted expenses, resulting in an operating net loss of -\$420,729 (a net loss of -\$843,037 when including capital project expenses).

Year-End Projection

We are currently are projecting a year-end operating loss of -\$395,988 (a total loss -\$818,295 including capital project expenses). These figures result from district revenues at the rates either published by PDE in November of 2017 or the district-calculated rates submitted to the state on form PDE 363. If Penn Hills School District is billed at the 2016-2017 rate, which PDE stated in April was acceptable, the school could receive an additional \$337K. This can be done during the year-end reconciliation process in July.
