#### **Balance Sheet Notes**

As of June 30, the end of the fiscal year, there was \$307,277 in cash, representing 17 days of cash on hand (benchmark = 60 days) and a current ratio of 1.8 (benchmark = 2). Cash was low because no major tuition payments were received in May or June. By July 31, cash was up to over \$1.4M due in large part to tuition payments received from Penn Hills School District. As of June 30, there was \$1,066,662 in outstanding 2017-18 tuition, but this figure was down to \$107K by July 31.

#### **Income Statement**

As of June 30 (the end of the fiscal year) we recognized 98% of budgeted income and 101% of budgeted expenses, resulting in an operating net loss of -\$149,546 (a net loss of -\$574,353 when including capital project expenses). There was an increase in revenue between May and June because of the increased Penn Hills School District tuition rate.

As a result of the **Statement Regarding Rescission of the** <u>Guidelines for Form Completion, PDE-363,</u> <u>Funding for Charter Schools (July 2012)</u>, issued by the Pennsylvania Department of Education (PDE), per-student subsidy rates were recalculated pursuant to section 1725-A of the Charter School Law. Should the recalculated rates be accepted by PDE at some later date, the school's net income for 2017-2018 will increase by \$159,615.
